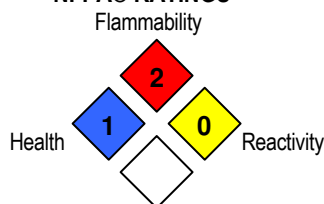
Safety
